

# **CAMPSITE REGULATIONS 2022**

This Regulation applies to all persons in the Camping  
LES DEUX RIVIERES, whatever their quality.

Staying in the campsite implies acceptance of this regulation and the commitment to abide by it.

## **OPENING – CLOSING OF THE CAMPSITE**

The campground is closed from the 4 October 2021 to 12 May 2022, and from the 3 October 2022.  
There can be no derogation in any way from this rule, as no one is allowed to enter the premises.

## **RECEPTION**

Open from 8:00 a.m. to 12:00 p.m., and from 2:00 p.m. to 8:30 p.m. (July and August).

All information on the campground services, information on refueling opportunities, sports facilities, tourist resources in the vicinity, and various addresses that can be useful.

A claim book or a special box intended to receive claims is kept available to campers in the sanitary.

## **CONDITIONS OF ADMISSION AND STAY**

Before anyone may enter the campsite, either to visit or to camp, they must first receive authorization from the Office Manager.

No one can elect home.

Anyone who either camps or brings a caravan on to the site accepts the regulations, as laid down by the management, and is bound to conform with it.

Anyone who is in breach of the regulations is liable to be expelled. If necessary, the police will be called non compliance will result in an immediate eviction without notice or refund.

## **POLICE formalities**

Unaccompanied minors of their parents will not be admitted.

Any person who has to stay at least one night in the campground must first present to the manager or his representative, his identification, and complete the formalities required by the police.

## **INSTALLATION**

**The arrival is between 2:00 p.m. and 8:00 p.m. and the pitch must be vacated at 12:00 a.m..**

The tent, caravan or motorhome and equipment must be installed in the location indicated in accordance with the instructions given by the manager or his/her representative.

One pitch and one electrical connection per caravan or motorhome will be allocated.

Users must respect the general aesthetics of the campground, in particular, the parcel shall not be encumbered by any other installation, or movable property other than the tent, caravan, motorhome, or related equipment, in accordance with the Regulations on the open air Hotel.

## **PAYEMENT OF CAMPSITE DUES**

These are payable at the reception office, in accordance with the printed rate for each reserved night. Campers are requested to inform the Office the day before their departure. Those intending to leave before the opening hours of the Office in the morning must ensure that they pay their account on the day before.

For all early departures (whatever the reason) no reimbursement will be made.

## NOISE

**Total silence is required from 10 :00 p.m. to 8 :00 a.m..** Campers and their pets must not make any noise which may disturb their neighbours. Particularly, campers must speak quietly, use TV sets, radios, record players with “reasonable” sound, and take care when shutting car doors and boots.

## VISITORS

The management will not be responsible for any loss, injury or damage suffered by visitors.

After being authorized by the management, visitors can be admitted to the campground under the responsibility of the campers who receive them.

The camper can receive one or more visitors at the reception. He must declare their identity

If these visitors are allowed to enter the campground, the camper who receives them may be required to pay a fee which is displayed at the entrance to the campground and at the reception desk.

Visitors must park their vehicle at the entrance of the campsite

**Visitors do not have access to the swimming pool.**

## PETS

Dogs and other pets are allowed into the campsite on the express condition that they don't disturb other campers in any way.

The vaccination booklet as well as the passport and the tattoo card will be presented to the reception desk on arrival.

They must never be left in freedom, they must be kept on a leash. They must not be left at the campground, even in the absence of their owners who are civilly responsible for them.

The owners are responsible for the cleanliness of their animals.

In accordance with article 21166-1 of the Rural Code, and the ministerial decrees and orders of application, the dogs of **Category 1 are prohibited.**

The Dogs of **Category 2**, whose owner will present his permit of detention at the reception office, must be muzzled and kept on a leash by a major person.

## DRIVING AND PARKING VEHICLES

The only vehicles which may come on to the campsite are those belonging to campers who are authorized to stay.

**Drivers must obey all traffic signs and respect the speed limit of 10 km/h.**

**Traffic is not allowed between 10:00 p.m. and 8:00 a.m..**

Parking at the entrance: users are invited to take the usual precautions for the safeguarding of their vehicle and equipment.

Parking must not impede traffic or prevent the installation of new entrants.

In the middle of the season, vehicles will have to park on the parcels of their users or on the parking lots located at the entrance.

**Parking is prohibited on public areas**

## LOOKING AFTER THE FACILITIES

Campers must do nothing to damage the cleanliness, hygiene or appearance of the campsite and sanitary. Waste water must not be thrown on the ground or in the river.

Caravanners must :

- empty waste water into the provided basins,
  - empty their chemical toilets into the "Vidoirs Chimiques" provided for this purpose.
- Garbage, paper and all kinds of waste must be put into the dustbins and recycling bins provided for this purpose on the right at the exit of the campsite

It is forbidden to wash cars inside the campsite.

Washing is strictly forbidden outside the bins provided for this purpose. The laundry will be extended to area for hanging washing. However, it will be tolerated up to 10 hours near the shelters, provided it is very discreet and does not hinder the neighbors. It should never be done from the trees. Plantations and floral decorations must be respected. Campers are forbidden to plant nails in trees, to cut branches, to make plantations.

It is not allowed to delimit the location of an installation by personal means or to dig the ground. Any damage done to the vegetals, fences, soil or facilities will be charged to the person who is recognized to have committed it.

The location that will have been used during the stay must be maintained in the condition in which the camper found it when it entered the premises. It is strictly forbidden for users to connect directly to the water pumps.

Electrical power supplied: 10 amps. **It is forbidden to use more than one electrical connection per location.**

## SAFETY

### a) Fire:

Open fires (wood, charcoal, etc.) are absolutely forbidden. Stoves must be guaranteed in good working order and be installed in mind their danger. Fire extinguishers are available to all.

In case of fire, use as quickly as possible the fire extinguishers which are at hand and immediately warn the Office, which also have a first aid box.

### b) Theft:

The management is responsible only for the items deposited in the office. Although some degree of safety and security is provided, campers are asked to take the usual safety precautions for the protection of their materials and personal possessions. They are also asked to immediately warn the Office Manager about anybody suspicious on the site

### c) Swimming Pool

**Children who are not able to swim and are not accompanied by an adult should not enter the pool area alone.** (there is no lifeguard). For groups of children, Recreation centre, a copy of the bathing Supervisor's diploma held by one of the group's accompanying persons will be requested. Without presentation of this document at the time of the return of the rental contract, access to the pool will be formally forbidden during their stay. Also when they use the swimming-pools the management disclaims all responsibility in the event of accident.

## d) Rivers

**Warning:** It is strictly forbidden to bathe in the rivers La Challore, la Canche and La Celle.

We remind parents that it is strictly forbidden for their child, or under their responsibility, to play alone in the vicinity of the rivers. Children must continually be under immediate supervision and must not play or walk alone around these water points.

In the event of an accident, the management disclaims all responsibility.

For obvious reasons of safety, under no circumstances will minor children be left alone on the campground or in the rental premises.

## GAMES

No violent or disturbing game will be tolerated near the facilities.

The meeting room cannot be used for hectic games.

Children must be constantly watched after by parents, specially when they use the sanitary facilities, where they are strictly forbidden to play.

## “DEAD GARAGE”

It may not be left unoccupied material on the ground, only after agreement of the management, and only to the location indicated. A fee, the amount of which will be posted at the office will be due for the "dead Garage".

## DIVERSE

Each caravan can install a removable canvas canopy in front of or on the side. It is strictly forbidden to put two. No development may be carried out on the sites without prior written authorization from the campsite manager. The locations will only be for recreational use. In no case will users be able to elect their home, to install their main residence: The campsite is a leisure activity.

## DISPLAY

These Rules of Procedure are displayed at the entrance to the campground and at the reception desk. It is given to the customer at his request.

For the classified land, the classification category and the number of places are displayed. The prices of the different services are available at the reception.

## DEGRADATIONS

Any degradation will be the subject of a repair invoice and will be the responsibility of the customer, through his insurance or not. It is expressly recalled that children are under the responsibility of their parents.

## VIOLATION OF THE RULES

In the event that a resident disturbs the stay of other users or fails to comply with the provisions of these Rules of procedure, the manager or his representative may, orally or in writing, if he deems it necessary, place the latter in Stop the Troubles. In the event of a serious or repeated breach of the rules of procedure and after the manager has made a formal notice to comply with it, he may terminate the contract.

In the event of a criminal offence, the manager will be able to appeal to law enforcement.
